The latest on College reorganization, funds released

One issue that has come up frequently in the informal faculty meetings we have been having this semester is that of college organization. I think you know as much as I do at this point, but I'll recap.

Provost Aeschleman has expressed a desire to create an applied science college at Appalachian to strengthen our programmatic efforts in those disciplines. This has been my desire as well. We have many excellent departments and program areas within the current college structure that struggle to be seen and appreciated to their fullest. I cannot tell you how many times I have been called upon to try to explain the name and structure of the college to potential donors or friends of the college.

Dr. Aeschleman will be bringing consultants to campus to look at our college, as well as the Mariam Cannon Hayes School of Music, with the goal of providing us direction in developing a more homogeneous model. The consultants are coming from College of Charleston and will visit with us April 12 and 13.

The team will be led by the Provost, Dr. Elise Jorgens, and will include Valerie B. Morris, Dean, School of the Arts, and probably Dr. Christopher W. Starr, Department Chair of Computer Science. Your chairs either have or will discuss if you as a departmental faculty wish to meet with them.

Another component of this process has already occurred; Dr. Bobby Sharp, Dr. Ozzie Oswald, and Heather Langdon visited with East Carolina University to study the impact of the arts being assembled into one college on their campus. This college is called the College of Fine Arts and Communication and was created in 2003. They will report to

the Provost shortly.

The consultants will report to him later in the spring semester, and the Provost has stated their report will be made public, regardless of what portions of it we may or may not adopt.

Changing subjects.... We have had a relatively good budget year, although there is never enough! This past week we put out to the departments the money we had been holding as lapsed salary funds, holding back \$20,000 for any possible emergencies. That is the pool of funds from which we pay for part time faculty, undergrad instructional assistants, etc., and we hope we will not need any of that for the rest of the semester. We had around \$200,000 released, and that was divided within the departments, based on the projects you and your chairs had put forth as critical. Obviously, any one department could have spent that amount, and more.

Fundraising Corner

"Sow Me The Money!?"

Private giving provides the lifeblood for academic programs within our University. State-appropriated dollars from Raleigh simply do not provide enough resources for our Provost, Dean and Chairs to fully fund important programs throughout our College. This is where I as your Development Officer may be able to help you "sow" the fundraising field.

Since joining the F&AA team in May 2006, I have met with each Chair to discuss particular fundraising projects within their respective departments. We continue to meet to discuss fundraising projects as they are ever-evolving. I encourage all faculty to contact your Chairs with any fundraising requests or specific funding needs.

Before meeting with your Chair, I recommend that you follow this three-step process:

- 1. Write a "Case for Support" statement (the who, what, when, where and why of the concept) outlining your project. This is normally one page in length.
- 2. Develop a workable timeline for your funding needs (next semester, next year, in the next five years, etc...) allowing enough time for us, together, to "sow the fields."
- 3. Research and then create a prospect list of who (individuals and corporate foundations) can help fund your projects.

Once you have completed these three steps, present them to your Chair for review. Upon approval of the Chair, we and your Chair (or their designate) can then plan an appropriate strategy to secure private funding for your particular project.

Thank you to everyone within the College who I have met and worked with this academic year. I truly hope to work with many more of you in the future to help secure funding for your important projects.

Mick Kresock (Technology) received the MCNC Appreciation Award during NCREN Community Day Dec. 8, 2006, held on the MCNC Campus in Research Triangle Park. The award was presented by John Killebrew, director of the North Carolina Research and Education Network. "You've led our working groups to have a terrific focus on quality and on the processes underlying the achievement of quality. John C. Quindry (HLES), an assistant professor in Appalachian State University's Department of Health, Leisure and Exercise Science, will spend the next two years studying the role short-term exercise plays in protecting the heart muscle during a severe heart attack. Quindry has received an \$180,000 Academic Research Enhancement Award from the National Institutes of Health (NIH) to conduct the study.

Advising 101

Catalog Year

It is the student's choice as to what catalog he/she wishes to follow to complete academic requirements as long as the catalog is not over six years old and as long as the student was in school at that time. No student can be told that a particular catalog year must be used. Exception: If a student returns under the forgiveness policy, the catalog in effect when they re-enter or thereafter must be used.

How to figure a catalog year:

2001-2002 Catalog

+ 6 Years

2007 -2008

(the student must finish by the summer of 2008 to follow this catalog)

If a student enters in Spring of 2007 or Summer 2007, the catalog under which he/she entered would be the 2006-2007; however, as stated above, the student may choose a later catalog.

All requirements must be completed under one catalog. A student may not follow a major in one catalog and a minor in another catalog.
